
## REBUTTAL TO ARGUMENT IN FAVOR OF SANTA CLARA COUNTY MEASURE L

The "crisis" isn't REVENUE; it's SPENDING! 7 · Additionally, homeowners are STILL repaying \$144,000,000 of Fremont Union High School District's infrastructure bonds. 70 · Last March, Proposition 55 authorized \$12,300,000,000 more to relieve 15 overcrowding/repair older K-12 schools! · The argument in favor claims, "There is no more administration to cut and no untapped sources of funding." As long as any administration exists there is still some room for 30 possible cuts. Local individuals, businesses, and alumni could be tapped for donations as a source of funding. 17 Why another tax that only property owners pay? 8 Homeowners are on a property taxing merry-go-round. How many different "creatively 13 labeled" property taxes are necessary? When is enough enough? When do tenants and 13 exempted seniors (Fremont Union High School District offers seniors exemptions for votes) 8 pay their fair share? Tenants and senior homeowners (56.66% of the electorate) escape taxation. To the District "the ends justify the means." Only residents vote, whether or not they are homeowners. It's unfair for the majority who WON'T be paying Measure L to vote for 31 more property taxes!
