The opponents are uninformed in their criticism of Measure M.

The facts speak for themselves:

The high cost of living in our area and shrinking school budgets make it difficult for CUHSD to maintain competitive teacher salaries with surrounding districts. Passage of Measure M is important for recruiting and retaining quality, experienced teachers.

The argument that Prop 98 will protect local school funding is simply wrong. As the Mercury News cited on July 1, "The Governor's plan **suspends Proposition 98**...and would increase that debt [to education] to \$5.2 billion."

These enormous state deficits have forced CUHSD to make tough cuts to educational programs and make it increasingly difficult to keep qualified teachers.

Measure M is the **only way** to raise funds that are **guaranteed** to stay in the Campbell Union High School District and no Measure M funds can be taken by the state or used for administrative salaries. Naysayers will try to confuse the issue by discussing state funding, but Measure M is entirely about and for our local schools and community property values.

Measure M will be assessed for only 5 years.

Campbell Union High School District has always been fiscally responsible. Measure M is the first time in the district's 104-year history that CUHSD has asked for the community's help.

On November 2, help our local high school students prepare for the future and protect strong local property values— Vote YES on Measure M.
