REBUTTAL TO ARGUMENT AGAINST

20 Measure N is being supported by local business leaders, parents, teachers and community members who care about our local schools.

25 We know the Evergreen School District has a strong record of fiscal accountability. We know the District has already made significant cuts due to decreased funding from Sacramento. We know funding from Sacramento is not expected to be sufficient next year. We know the only way to make sure our 30 children have a quality education is to provide local funds that go directly into our local schools.

34 Outside anti-tax crusaders make the same arguments against Measure N they have made throughout the
County. But those of us who live here know our School Board has committed these funds to academic
35 programs that will make a difference. And we know it is better to have those funds administered by a
local school board accountable to local citizens than it is to rely on unstable state funding.

37 We know older citizens can apply for an exemption, and that the cost, less than \$8 per month, is a
reasonable amount that won't create undue hardship for anyone. We know this funding will only last for
four years, long enough to ensure we get through these difficult times, and that it cannot be renewed
21 without voter approval.

38 In short, we know Measure N is good for our schools, good for our community, and good for our children. That is why those of us who live and work in Evergreen are united in supporting Measure N.
